AMR Program Staff Highlights (November 2006 to January 2007)

Regional Coordinator's (RC) Highlights

- Presented as a Panel Member on Luzerne County Environmental Issues and Regional Abandoned Mine Land Issues at the 16th Annual Small Cities Conference, Wilkes-Barre, sponsored by the Joint Urban Studies Center; 125 attendees
- Guest Speaker at the first-annual PA DEP COALS Summit on "Citizen Engagement" that was held at Luzerne County Community College to talk about the Luzerne Conservation District's AML Program and EPCAMR's role in assisting communities to cleanup abandoned mine illegal dump sites; 120 attendees
- Participated in 2 COALS Cleanup Projects: Hicks Creek Watershed AML Cleanup in Exeter Borough, Aaron Szwast, Karen Szwast, LCCC Environmental Club Students, Boy Scouts, and Wyoming Area and Seton Catholic High School Students; 450 tires were collected and 6.5 Tons of trash were removed from 2 sites, with 50 volunteers participating and the Avondale Mine Disaster and along the abandoned Delaware, Lackawanna, & Western RR grade in Plymouth Township; Removed nearly 60 tires and 1.5 Ton of debris from the sites with over 30 community volunteers participating
- EPCAMR Program Staff conducted 2 Education & Outreach Watershed Tours: PA DCNR's Community Connections, Watershed Forum Program, throughout the Wyoming Valley with 8 teachers from 8 school districts in Luzerne County, and 40 students and 24 Hazleton-area home schoolers and nearly a dozen parents to the Audenreid AMD Remediation Site and the Green Mountain Tunnel
- Completed an ASAP Enrollment Process for EPCAMR with the Office of Surface Mining to migrate into their new mandatory online accounting and electronic file transfer payment system for all of their grants
- Prepared 3 letters of support for grants that were submitted by the Lackawanna River Corridor Association (LRCA) [1] and the Eastern Middle Anthracite Region (EMARR)
 [2]
- Submitted a PA DEP BAMR AMD-06 Grant proposal with Chris Gillis, Eco-Tech LLC. to produce a bench scale innovative treatment system remediate abandoned mine drainage and recover iron oxide from the Old Forge Borehole, Lackawanna County
- EPCAMR received 3 Growing Greener Grant Awards: Hicks Creek Stream Restoration, Mine Pool GIS for the Southern and Western Middle Anthracite Region and the AMR Program Support (LCD).

Watershed Outreach Coordinator's (WOC) Highlights

- Started a Surface Water Infiltration Points GIS Database which covers most of the Eastern Middle and Northern Anthracite Coal Fields. Continued to add Mine Pools to the EPCAMR Mine Pool GIS Layer including the Lackawanna Valley and Bernice Mine Basin in Sullivan County.
- Completed the Nescopeck Creek Watershed Restoration Assessment Plan which shows site specific information and maps for each AML Site and overall statistics for the watershed. Copies are available through Friends of the Nescopeck. Began a similar report for Solomon Creek, Luzerne County.
- EPCAMR Staff developed an estimated budget for 2 partnership EPA Grant Proposals submitted by the Eastern Coal Region Roundtable (ECRR) and Trout Unlimited (TU) that would allow our Program to assist with conducting additional PASSING GO Organizational Development and Capacity Building Workshops for community groups
- Printed 3 GIS Maps for schools, municipalities and partnering groups. Updated the PA AMD AML GIS CD, now called RAMLIS, to v.6.3 with 2004 Color Infrared Aerial photos, 2005 Color Aerial Photos and Political boundaries for all of PA live from PASDA.
