AMR Program Staff Highlights (February 2007 – April 2007)

Regional Coordinator's (RC) Highlights

- AMR Program Staff Co-hosted the PAEE Conference, conducted a Wyoming Valley AMR Tour and presented as a Keynote Speaker in Wilkes-Barre on EPCAMR's Placed-Based Environmental Education Programs & Philosophy; 125 environmental educators attended
- Prepared 12 letters of support for the PA EnviroThon and sent to legislators
- Received \$6000 in discount coupons from DICK's Sporting Goods for the Youth Fishing & AMD Watershed Tour Program with the PA F&BC
- Participated in 1 COALS Cleanup Project and Coordinated 1 COALS Tour for PA DEP, PGC, and PEC throughout the West Side of the Wyoming Valley: Avondale Hill-Bureau of Forestry Lackawanna State Forest West Nanticoke Tract (AML impacted), Plymouth Township; 60 tires were collected and 4 Tons of trash were removed with only 7 volunteers in 5 hours
- AMR Program Staff conducted 3 AMD Education & Outreach Watershed Programs & Tours: PA DCNR's Community Connections, Watershed Forum Program, throughout the Wyoming Valley and at the Old Forge Borehole, Lackawanna County with a combined total of 14 teachers and 128 students
- **1,100** 4-7th graders attended a AMD Tie-Dye Workshop at the Earth Day Festival in Wilkes-Barre
- Reviewed 22 grant proposals for technical merit and provided a letter of support / acknowledgement for the Growing Greener Grant Round, the C2P2 PA DCNR Grant Round and the Toyota Tapestry Grant as requested
- AMR Program Staff submitted 1 Growing Greener Grant: The AMR Program Support (LCD) for fiscal year 2008-2009 for \$123,500
- AMR Program Staff presented to the American Mushroom Institute in Avondale, PA on potential partnership opportunities between mushroom growers, watershed groups, and land reclamation-oriented organizations
- Nominated by OSM/Pittsburgh Office to become a member of the OSM Technical Information Processing System (TIPS) National GeoSpatial Data Standards Task Group to represent PA's environmental interests in assisting with the development and implementation of a uniform National Data Standard and layer for Surface Coal Mining Boundaries, Underground Coal Mining Boundaries, & AML Inventories for the Coal-Producing States
- Attended an Organizational Capacity Building Workshop sponsored by William Penn Foundation and facilitated by the Institute Conservation Leadership (ICL) in Pottsville as a requirement under the WPF Grant with Stell Environmental Enterprises
- AMR Program Staff attended and presented at the ACCWT Training. Learned a new technique to estimate flow using only a 3' Aluminum Straightedge. The measurement will be right 90% of the time in flows that range between 1" and 18"

Watershed Outreach Coordinator's (WOC) Highlights

- EPCAMR program staff are working toward the SMCRA Reauthorization Education and Outreach Program in cooperation with WPCAMR. Andy McAllister is working on a video that will provide an overview the changes with a bit of levity.
- Updated the PA AMD AML GIS CD, now called RAMLIS, to v.6.3 with 2004 Color Infrared Aerial photos, 2005 Color Aerial Photos and Political boundaries for all of PA live from PASDA.
- Produced 11 maps for EPCAMR Partners and added information to 3 EPCAMR GIS Databases.
- Aiding the AMR Conference Steering Committee as we gear up for the Conference in July. Setup a webpage, led several conference calls and kept minutes.
