# Watershed & Cooperating Organization Reports - October 25th, 2007

## **Presidents Report**

Attended the Susquehanna River Watershed 2nd Annual Symposium and co-presented with Robert on EPCAMR's
efforts.

#### Catawissa Creek Restoration Association

Oneida 1

• Completed. System is producing 17mg/l alkalinity, fish in trout pond thriving and fish seen in the stream. Fish reported in Catawissa Creek now down to Shumanstown.

#### Audenried

• Finishing redesign on intake. Had a meeting with DEP regarding that. Having problems with land owner communication / consent since the change over of the property owner. Even though the system was damaged by the blow out it is still functioning at about 30% capacity. Since adding the new smaller sized limestone pH now comes out at about 6 with 25 mg/l of alkalinity (increased from pH 5).

Looking to use the biosolids in Sullivan County to substitute for topsoil on AML. Mixing with lime in with a machine which heats, mixes and grinds.
- One acid mine drainage system is emitting an odor. The newly revamped SAPS. The mushroom odor from the compost layer was supposed to subside within 3 weeks and has not yet.
