AMR Program Staff 4th Quarter Highlights (April 2008 – July 2008)

Regional Coordinator's Highlights

- Prepared 15 Letters of Support and 3 Letters of Acknowledgment for regional groups upon reviewing GG and DCNR Grant Applications to the Commonwealth
- EPCAMR Staff completed the EPCAMR Program 319 Growing Greener Grant that was submitted to the PA DEP for FY09-10 for **\$123,500**
- Provided an EPCAMR Letter of Support for the SRBC proposed Consumptive Use Mitigation Fee Increase and a Letter of Support to the PA Anthracite Council at the request of Duane Feagley, Executive Director, on supporting remining incentives for the Anthracite Industry to OSM
- Meeting with Carly and John Dziak-Greater Pittston Historical Society to prepare a **\$1000** grant application to OSM/VISTA and the ACCWT for a Summer Associate (Anthracite Historian Research Assistant) 10 week full-time intern to work with John and EPCAMR on developing some historical anthracite related learning packets, a web-site for regional historical resources on abandoned mines, history, and people, places, and events;
- Informed the EPCAMR Board the our EPCAMR PA Sales and Use Tax Exemption as an Institution of Public Charity has been approved, retroactive to January 9,2008 and will need to be reviewed again in 2013
- Coordinated and conducted two AML cleanups- Avondale Mine Colliery and LCD Wetlands Area; 226 bags of trash removed, 70 tires, 3150 pounds of metal collected, 28 volunteers
- Exhibited at the LRCA RiverFest, the Schuylkill County Bear Creek Festival and the Wyoming Valley RiverFest ~ 275 AMD Tie Dye T's created
- Co-presented with Mike at the PA Council of Geology Professionals "Water & the Environment" Symposium on EPCAMR's RAMLIS GIS Tool at their Annual Meeting in Hershey
- EPCAMR Staff conducted 2 AMD/AML Outreach Programs with Blossburg Elementary and Dallas Elementary for 288 students in the 4th & 5th grade

Watershed Outreach Coordinator's Highlights

- Produced 18 maps, and 6 sets of statistical data for EPCAMR partners through GIS
- Finished RAMLIS v.8.0 and began distribution (so far 25 copies have been sent). Working availability through our website (via download and/or interactive with Google maps)
- Modified 5 GIS layers for the Mine Pool mapping Program to give to the USGS. Began building 3D structural contours from USGS C-Series Coal Investigations Maps to aide in 3D modeling of mine pools in the Western Middle Coal Field.
- Aided several groups in the region with Growing Greener proposals. Worked in depth with 3 in particular: the EPCAMR Program Funding to the 319 Program, the Honey Pot (Susquehanna #7) Discharge Treatment with SRBC, and the Old Forge Borehole Treatment with EcoTech.
- Presented at a Community Connections Watershed Forum, and a Northumberland CCD Board Mtg. Co-presented at the PA Council of Professional Geologists Symposium, and the Northumberland and Lackawanna Co. Stakeholders Mtgs. with Regional Coordinator. Conducted 1 AMD Tour, a 1 day field investigation, and 2 interactive EE events with VISTA.

- Faxed letters to 35 AMD-impacted municipalities in the Wyoming Valley watershed; offered assistance with watershed-related projects.
