Education & Outreach

- Completed PA EnviroThon Background Check information and paperwork and submitted it to Lorelle Steach, PA EnviroThon Program Coordinator; EPCAMR Staff updated its Criminal Background Checks and PA Child Abuse Clearances; Cleared our purchases for the program with the PA EnviroThon who gave us the go ahead to invoice them following the purchases of the totes, baking soda, and rubber bands for the AMD Tie Dye Program on the 21st of May; Asked WPCAMR to participate in the Program and Anne Daymut, Watershed Specialist is working out her schedule to attend; Made arrangements to stay at R. John Dawes' Farm Cabin in Huntingdon, PA the evening before the event; Forwarded the directions for the AMD Tie Dye Activity to Lorelle Steach for her to print for the day of the event-http://epcamr.org/storage/IronOxideTieDyeActivity.pdf
- EPCAMR Staff pulled together our display materials, handouts, and videos for our "Community Organization of the Night" sponsorship by the Scranton-Wilkes-Barre Railriders AAA Team, at Montage Mountain, Moosic, PA; EPCAMR was the 2nd regional non-profit featured on Opening Week of the newly formed AAA Team of the New York Yankees; Threw out the first pitch; Interviewed by the local radio station broadcasting the play-by play for the game; and had a chance to meet with Railriders Community Relations Staff that allowed us to get an on-field interview in front of several thousand baseball fans on April 5th, 2013 that provided us with a once in a lifetime outreach and awareness opportunity
- Attended the GIS Discovery Day at King's College, Luzerne County, to speak with
 undergraduate students about the importance of GIS in our field of interest, its applications for
 abandoned mine land reclamation, AMD remediation, and watershed restoration; Talked with
 students about the value of internships and volunteering with community groups like EPCAMR
- Scheduled an Earth Fest 2013 Educational Program in with the Bear Creek Community Charter School, Luzerne County for September 13, 2013 for the 2nd year in a row at the request of their Environmental Initiatives Coordinator, Paula Longo;
- Received a North Branch Land Trust AML Resolution formerly adopted by their Board on March 21st, 2013; www.nblt.org

- Created and designed a webpage on our EPCAMR website for our newly accepted Fishing
 Tackle Loaner Program in partnership with the PA Fish & Boat Commission;

 Submitted a Work Rules acknowledgement form to the PA Fish & Boat Commission's Regional Outreach & Education Coordinator, Walt Dietz
- Target Field Trip Grants 2012-2013 are open to school districts; More than 5,000 schools received \$700 field trip grant; Target funds programs that allow students and teachers to learn in all kinds of settings. They fund field trips that connect students' classroom curriculum to out of school experiences; Found another Project Learning Tree grant as well; Forwarded to the W-B Area School District Science Coordinator Mike Corcoran
- Attended the Luzerne Conservation District's County EnviroThon to serve as a Volunteer Judge and Scorer for the Soils Section of the competition at the request of Aaron Stredny, Watershed Specialist
- Submitted a self-nomination to the US EPA, National Environmental Education Advisory Council
 in response to the vacancy on the Council and the need for a regional non-profit environmental
 organization to be represented on it that has a deep connection to Environmental Education
 (EE); EPCAMR is heavily involved in EE and is represented on the PAEE Advisory Board,
 member of PAEE, PAEE Non-Formal Environmental Education Certification Working Group, PA
 EE Non-Formal Environmental Education Advisory Board, and is certified in Project WET,
 WILD, PLT, and KARE Educational Programs; EPCAMR is working with PAEE through the
 North American Association of Environmental Educators (NAAEE) to provide the Non-Formal
 EE Certification Program in PA
- Worked with Mel to send out EPCAMR Volunteer Registration Forms (VRFs) to all of our interested Community Volunteers; Reviewed his initial compilation database of EPCAMR volunteers from www.VolunteerMatch.org and checked for any edits, misspellings in names, corrections, and cross-referencing with any existing information EPCAMR may have on the volunteers
- EPCAMR created a News Post on an upcoming Marcellus Seminar for teachers and
 educational professionals at Mansfield University at the request of a colleague of ours, Jen
 Demchalk, who is a Professor at Mansfield and environmental professional in the field of AMD
 Remediation; Jen will be providing EPCAMR with a free copy of the toolkit for the Program once
 it is developed for our assistance in helping to get the word out to teachers in the region;

- Signed EPCAMR on to a Choose Clean Water Coalition (CCWC) letters supporting and thanking Congressman Matt Cartwright's sponsorship of HR 1175, the Focused Reduction of Effluence and Stormwater runoff through Hyrdofracking Environmental Regulation Act (FRESHER) of 2013, which will go a long way to protect clean water in the Chesapeake Bay watershed; Congressman Matt Cartwright (PA) had introduced legislation attempting to close a Clean Water Act loophole relating to oil and gas development as a means to decrease

stormwater runoff. The Clean Water Act was amended in 1987 to extend authority over the permitting of industrial stormwater, but oil and gas development was exempted; This was further expanded in the 2005 Energy Policy Act; Cong. Cartwright's legislation –the FRESHER Act of 2013 – would amend the Clean Water Act to fix the 1987 exemption; The legislation would also require a study by the Secretary of the Interior on stormwater runoff from oil and gas operations the Secretary determines may be contaminated by stormwater runoff.; With a growing number of oil and gas wells in the region, the legislation would help to lessen the impacts of stormwater and sediment to our surface waters in PA

- EPCAMR worked within Congressman Cartwright's District on many environmental projects that relate to clean water and wildlife habitat and stream improvement projects within NE and NC PA; EPCAMR sent a letter to encourage and see if Congressman Cartwright sign on to the "Dear Colleague Letter" attached upon his review to keep the State and Tribal Wildlife Grant Program alive and funded; EPCAMR works with our state PA Game Commission on many projects that are related to endangered species, such as the Indiana Brown Bats around abandoned mine site closures, planting warm and cool season grasses on abandoned mine sites to increase songbird habitats and wildlife on the reclaimed sites, and on other projects with the PA Fish & Boat Commission related to habitat and stream improvement projects in trout streams across NE and NC PA
- Bear Creek Community Charter School CEO, Jim Smith, provided EPCAMR with a support letter for our submission to the PA DCED EITC Program for 2013
- EPCAMR signed on to a letter regarding appropriations with the Choose Clean Water Coalition; As a reminder, the President's 2014 Budget came out on April 10 and that jumpstarted the appropriations process in Congress; Engaging in the appropriations process helps to fulfill one of the CCWC 2013 policy priorities "promoting federal investment for Chesapeake Bay watershed restoration and protection efforts and defending against attempts in Congress or the Administration to weaken or eliminate them"; Most of the Interior letter requests the President's Budget number for 2014; In the EPA Chesapeake Bay Program section we are asking for particular language to prevent EPA from making discretionary cuts to two important grant programs run by the National Fish and Wildlife Foundation (NFWF); Also, the letter is requesting a Clean Water State Revolving Fund amount that is greater than the President's budget request
- Corresponded with Mike Bedrin-PA DEP NE Regional Director about a potential environmental issue of concern in the Lackawanna River Watershed; EPCAMR was informed by Bernie McGurl, Executive Director of the Lackawanna River Corridor Association (LRCA) and who currently serving as President of EPCAMR that the American Rock Salt Company has acquired land along the Lackawanna River for a Rock Salt Storage & Distribution Center; EPCAMR was informed that they have applied to the Department of Environmental Protection (PA DEP) for a permit to discharge stormwater retention ponds into the River; Stormwater generated from these facilities can contain dangerously high sodium levels which severely impacts aquatic life; We would be very interested in hearing how this company is planning on reducing the potential for the increased sodium levels that are commonly associated with rock salt; EPCAMR had respectfully requested that the PA DEP schedule a public hearing on this environmental

concern within the watershed; EPCAMR and LRCA, along with the SRBC have been working diligently and methodically to continue to move forward with addressing the AMD issues in the Lower Lackawanna River and adding an additional water quality issue to the mix could put us even further behind than what we are with addressing the AMD issues in the Lackawanna River watershed; The Lackawanna River stands to lose a lot of fish and a lot of water

Technical Assistance

- Meeting with Ken Eden of RT Environmental Services at the Office to see if we could assist in providing him with information, resources, reports, on the Huber Breaker, Ashley
- Partnered with SRI to conduct and complete a regional *Datashed Workshop* hosted by the EPCAMR Staff on April 12th, 2013; 12 users attended the workshop
- Attended the QuickBooks Made Easy! for Non-Profits Training Workshop at RMU, Pittsburgh, PA hosted by the Bayer Center for Non-Profits, in downtown Pittsburgh
- Provided a Ms. Diane Weiss, a private landowner, located just outside and upstream of our Hicks Creek Natural Stream Channel Design Project with information about our project and provided her with contact information and grant information that she may want to have Exeter Borough consider in the next round of applications for her property which is also experiencing streambank damage due to recent flooding over the years, but was not in our original scope of work because the abandoned mine land problem area was below her property and the damage was done well after we had already began working on our project; Made the call to her at the request of Senator Yudichak's Office and followed up with his office on our conversations with Ms. Weiss
- BF Environmental provided EPCAMR with a few boxes of free copies of their new booklet on private wells and drinking water quality in PA; This is an educational guide; http://www.water-research.net/privatewellownerbooklet.htm
- Provided assistance to the Huber Breaker Preservation Society by contacting PA DOT regarding the placement of directional signage in the right-of-way setback distance along PA DOT roads or highways to determine the placement of two signs directing people to the Huber Miner's Memorial Park in Ashley
- Informed Rusty Bennett, from the Mehoopany Creek Watershed Association that EPCAMR does have some funding available for small watershed restoration projects through our ARIPPA Mini-Grant AML/AMR Awards Program open until June 30, 2013 and that we encourage them to apply; http://epcamr.org/home/2013/arippa-aml-reclamation-funding-opportunity-through-epcamr/

Project Coordination

- EPCAMR was awarded an \$8,000 PA American Water Company Grant to implement several stream restoration and trout habitat improvement projects in the Solomon Creek Watershed, Luzerne County, PA located within their service area; Provided Susan Turcmanovich, Manager-Communication & Corporate Responsibility with EPCAMR's W-9 Form and provided her with a brief summary of the project for PAWC's Press Release
- Worked on adjustments to the SMCRA Lewis Mine Rehabilitation AMD Treatment System
 Project agreement application worksheets, task and deliverable worksheets, budget forms, and
 goals and accomplishments forms and submitted them to our Project Officer, Mario Carello, and
 the PA DEP Grants Center, Harrisburg before receiving the final grant contract agreement;
 Coordinated with Bob Hedin, Hedin Environmental, one of primary contractors in the upcoming
 project and Eric Rosengrant-PA DEP Moshannon DMO Inspector on obtaining the necessary
 water quality and quantity information for the initial submission paperwork
- Coordinated with the Hicks Creek Watershed Association, Exeter Borough, and all partners involved with the *Hicks Creek Natural Stream Channel Design & Construction Project*; Requested that the Borough Engineer ask the Borough if they would be the applicant on the Chapter 105 Joint Permit Application as opposed to EPCAMR to eliminate the need to pay the permit fees since the municipality is exempt from the fees; The permit could be transferred to EPCAMR for a transfer fee that could be reimbursed by EPCAMR to the Borough, otherwise EPCAMR will be paying an unanticipated \$1750 in administrative filing fees that will have to come out of the Construction budget line item to cover those costs; Submitted the E & S Plan for Administrative Review to the Luzerne Conservation District; PA DEP BAMR Project Advisor Dennis Palladino sent an extension request letter down to the Grants Center for a 1 year extension and is awaiting a response
- EPCAMR was awarded 1 of 8 Year 2 Waterboxx Research Project Grant Awards from the Appalachian Coal Country Team (ACCT) for \$2000 to continue monitoring the seedlings planted at the Huber Miner's Memorial Park and to plant an additional 40 seedlings in the coming year ahead in 2013; EPCAMR believes that our abandoned mine land site is unique and the detailed monitoring that we are continuing to conduct in addition to the information that ACCT is collecting will prove useful down the road and an additional planting of 20 more Waterboxxes along a streamside riparian corridor in the Solomon Creek watershed will prove to be valuable to the ACCT and Groassis
- EPCAMR Staff downloaded pressure transducer water quality data from the Old Forge Borehole
 for the Susquehanna River Basin Commission's Mine Pool Monitoring Project in the
 Lackawanna & Wyoming Valleys; Provided Tom Clark with a map of the Good Spring Mine
 Pools in the Southern Fields
- Meeting with Charlie Jones, First National Bank, who has a son that is becoming an Eagle Scout with the Boy Scouts of America, Troop #154, Kingston, PA, who partner with the Holy Trinity Lutheran Church, and needed a community service project to work on; EPCAMR has come up with a project that would allow his son to prepare and plant 20 of our 40 seedlings on the Huber Breaker Miner's Memorial Park site in the Summer 2013

- LRCA Executive Director, Bernie McGurl has given EPCAMR permission to place the entire
 Lower Lackawanna River Watershed Restoration and Assessment Plan (LLR-WRAP) on
 our website for public release; Previously, we have had only the Executive Summary posted
 online; Trying to schedule a meeting with Senator John Yudichak and Lisa Baker
- EPCAMR is continuing to work with a Wet Processor, Daniel Quiroga, from Southern California
 to provide him with several pounds of our iron oxide for a clothing line that he's working on for
 small boutiques in his area that are unique and are interested in the recycled nature of our iron
 oxide pigment and the color line it produces with garments that he is testing
