# Education & Outreach

- *Elizabeth Hughes*, EC informed EPCAMR that *Elizabeth Skrapits*, Citizen's Voice was looking for information on the Plainsville AMD Borehole; CV thought it was EC property; EPCAMR informed EC and the CV that it was owned by the Price Family and it was a former topsoil pit and before that farm fields; PA DEP drilled a relief borehole to prevent further collapse and flooding from occurring in Plains Township and flooded the topsoil pit with AMD; EPCAMR has plans to reach out the *Greg Price*, in partnership with the Luzerne Conservation District's Watershed Specialist, *John Levitsky*, to gain an access agreement to gather flow and chemistry from the AMD discharge prior to coming up with an AMD design concept plan for the discharge to present to *Mr. Price* that we might be able to pursue funding for in the future
- Reviewed and provided comments to *Dr. Margarita Rose*, King's College, PA on the draft Group Contingent Valuation survey that being compiled for the creation of a SurveyMonkey survey to assist EPCAMR and the Huber Breaker Preservation Society (HBPS) with creating some outreach and awareness of our collective work on the Huber Miner's Memorial Park reclamation and development; Preliminary survey data results will be presented by the students who are participating in a service learning project with EPCAMR and the HBPS at the Global Landscapes Conference at King's College on April 20<sup>th</sup>; Attended the Global Landscapes Conference with *Ray Clarke*-HBPS to evaluate the students work and poster sessions; https://www.surveymonkey.com/r/minerspark

- EPCAMR Staff made a trip out to Blair County to receive a grant award in the amount of **\$480** from *Dominion* and the *Western PA Conservancy* from Don Houser, Director of Regional Federal, State, and Local Affairs for Dominion; The grant will be used to produce a new updated EPCAMR Brochure to distribute to our partners and potential partners in the Tioga and Dauphin County coverage areas within our region

- EPCAMR Staff set up a Seed Bomb making station at the *Earth Festival* on April 29<sup>th</sup> at the Wilkes-Barre Nesbitt Park commons along the Susquehanna River where nearly **1000** elementary and junior high school students attended to visit various environmentally-related stations and conservation partners in Luzerne County; EPCAMR set up our EPCAMR Exhibit to show students the kind of work we do in the region
- EPCAMR to reach out to *John Welsh*, to see if he'd present at the June 30<sup>th</sup> Meeting of the PA Anthracite Section of the SME-AIME at Mountain Valley Golf Course; <u>www.ashleysbreaker.org</u>

- Provided Ryan Longenberger, a Senior from King's College with personal contacts from Engineering Firms and Consultant Companies since he was looking for an internship that provided engineering background and training in the field of environmental science; EPCAMR didn't have any available internship positions open at the time of his inquiry; Encouraged him to become an EPCAMR volunteer through GiveGab

## Project Coordination

- Requested follow up from *Eric Rosengrant*, Project Officer, PA DEP Moshannon Office for our *Lewis Mine AMD Rehabilitation Passive Treatment System Project* to see when the final payment will be released to EPCAMR to pay Rexers, LLC for their work on the construction end of the project and to pay Hedin Environmental for their design work; EPCAMR provided all close-out documentation and Rexers is requesting an idea of when the final payment will be made
- Reviewed a rough draft of the *Laurel Run CHP* provided by the EPCAMR Watershed Outreach Staff and provided comments and suggestions to be included in the final report; Provided *Gabby* and *Liz* with the sample Solomon Creek Field Data Excel File for the Benthic Macro Impairment Evaluations; Worked on securing a Wilkes University Conference Room in the Henry Student Center (2<sup>nd</sup> Floor) for the draft Laurel Run CHP meeting through *Megan Boone Valkenburg on* April 28<sup>th</sup> at 6:15-8:15pm; Forwarded the information to the local newspapers to see if they would pick it up to give us some publicity for the meeting; EPCAMR Staff found what appeared to be a leaky discharge or an open latch pipe from a sewer line behind the baseball field at Hollenback Park and reported it to the WVSA (*Jim Tomaine*) and WB City (*Butch Frati*) for further inspection; Heard from *Shawn Rummel*, TU that our request for an electroshocking survey Technical Assistance Grant (TAG) was approved and they are in the process of developing a scope of work for it; EPCAMR Staff still need to sample for macros in certain areas and decide what locations to monitor and shock to identify fish populations and a transition into the warm water area along Laurel Run; Received permission from *Mitch Kornfeld*, owner of the Woodlands Inn & Resort to access the property to conduct an electro-shocking survey and macro-invertebrate survey
- Followed up with *Paula Longo*, Bear Creek Charter School about picking up her Waterboxxes for our *Waterboxx Phase III Research Project* and informed the EPCAMR Watershed Outreach Staff; Submitted a request for \$4750 to ISI, LLC for a reimbursement and a progress report on the distribution of the Waterboxxes for the Spring of 2016
- Collected and collated In-kind reporting forms from PA Leadership Team Leaders for the *EE Capacity Grant* Phase I Reporting and Reimbursement submittal; Put information on the *Community of Learners EE Capacity Facebook Group* about the upcoming April 27<sup>th</sup> conference call and presentation; Contacted *Carl Jones*, Executive Director of the Office of Environmental Justice to participate on the call and reviewed some talking points and agenda development for the call

- Worked up a contract agreement in the amount of **\$7900**, for the Design Plans for the **Solomon Creek Trout Stream Habitat Improvement and Dam Removal Project** and provided it to RiverLogic Solutions, LLC and *Bernie McGurl*, EPCAMR President, for their review and signatures; EPCAMR will work up a separate contract for the eventual construction once we get an estimate back on the cost to remove a utility pole that is shown on the plan that will be impacted during construction; Informed Ben Lorson, Project Manager from the PA F&BC that the design plans should be completed shortly and will be forwarded to PA DOT
- Pioneer Tunnel is requesting that EPCAMR serve as a possible pass-through should some OSM funds to apply towards the construction of the headframe at the Pioneer Tunnel Museum; Provided a one page summary of EPCAMR services and technical assistance capabilities
- Submitted a letter of inquiry for **\$12,000** to the Foundation for PA Watersheds to complete a watershed assessment of the Gardener Creek and the remainder of the Mill Creek watershed in Luzerne County, PA
