## **Education & Outreach**

- Presented an Environmental Education & Outreach and AMD Tie Dye event with **24** teachers under the direction of *Elizabeth Thorpe*, PA Student Leadership Coordinator, from the Chesapeake Bay Foundation in Centralia, PA on August 8th as a part of a teacher training program
- EPCAMR Staff conducted an Environmental Education & Outreach Program for 24 youth from the PA
   American Water Summer Camp Program in the Lackawanna Valley at the Peckville Library about
   macros, macro sampling, fish, the health of the Lackawanna River, and how to create AMD Tie Dye T shirts at the request of the LRCA on August 1st in the Lackawanna River
- Directed Abbie to help publicize a cleanup event for the Huber Breaker Preservation Society through our August newsletter and the dedication ceremony event for the PHMC Historical Marker on September 4<sup>th</sup>; <a href="http://citizensvoice.com/news/volunteers-needed-at-memorial-site-1.2225788">http://citizensvoice.com/news/volunteers-needed-at-memorial-site-1.2225788</a>
- Followed up with *Dr. Jessica Nolan*, University of Scranton, Director of the Environmental Studies concentration, who is interested in bringing the Centralia Documentary to the University; EPCAMR will have to follow up directly with Joe Sapienza to see if that is a possibility over the Fall
- Completed a phone interview with Donna Morelli-Chesapeake Bay Journal writer who was writing a story
  on EPCAMR recent completed project with the City of Wilkes-Barre and LandStudies, Inc. under the
  NFWF Technical Assistance Stormwater Management Grant on the Green Infrastructure Plan we
  developed that will appear in the Bay Journal
- Reviewed PA AML Pilot Projects for 2016 as well as other projects in West Virginia and Kentucky with PA AML Campaign members and the National RECLAIM working group; The biggest problem with the list is the lack of details about the projects; Costs, benefits, additional sources of funding, stakeholder collaboration requirements met, timelines, etc. are still largely unknown
- Provided *Dr. Marianne Krasny*-Cornell University, with potential locations to display the upcoming SESYNC book that is being published by Cornell University Press where a chapter is co-authored by the EPCAMR Executive Director about his individual experiences growing up in the coal region

- Followed up with Beth Berkhauser, <a href="www.hexagonproject.org">www.hexagonproject.org</a> and discussed having her meet with Mrs.
   Michele Kordek at Greater Nanticoke Area School District to see if they are interested in incorporating using the hexagon AMD/Art project as an introductory program to demonstrate knowledge and as an assessment/evaluation tool to connect them with the international project; Her partner, Melissa also plans to tweak the AMD/Iron Oxide Unit Plan that all three of us having been working to create as a curriculum to be used regionally in the school systems throughout the Coalfields
- Talked with *Dr. Andrea Nerozzi*, Wyoming Seminary Upper School Advanced Environmental Science Professor about incorporating EPCAMR's work into her students Founder's Day presentation in the Fall 2017; EPCAMR Executive Director will take the students on a watershed tour and a visit through the EPCAMR Technical Assistance Center at our Office to provide a review of our work in the region; Discussions by the students will be on the environmental legacy of coal and what is being done to restore mining impacted lands and rivers and streams that are polluted by abandoned mine drainage (AMD); Introduced her to *Beth Berkhauser* and her Hexagon Project because *Dr. Nerozzi* is also an artist who has created artwork with EPCAMR's iron oxide pigment
- Reviewed the August draft EPCAMR Newsletter produced by Abbie Keefe-OSMRE AmeriCorps
   Volunteer, with help from Mike and the Executive Director before sending out to our mailing list and Board
   Members

### Technical Assistance

- Provided the Huber Breaker Preservation Society with the proper information that needed to be put into a
  document on HBPS Letterhead related to a Vendor Statement on the selection process for the contractual
  work on the Huber Miner's Memorial Park, Ashley, PA; This letter signed by Ray Clarke allowed for the
  payment process of invoices to continue to move forward so that Tetra Tech and others can be paid
- Provided comments to Ed McCrea, PAEE on a draft Financial Procedures document
- Reviewed responses from John Stefanko, PA DEP Deputy Secretary, Active and Abandoned Mine Operations, on draft comments submitted for the PA Environmental Good Samaritan Act amendment document sent to EPCAMR by Anne Daymut-WPCAMR
- Met with City of Wilkes-Barre Officials and a local resident, Terry Schwiotz, to explain to her the benefits of the W. Ross/W. River Street Green Infrastructure Infiltration Trench Project that was constructed as a part of our NFWF Stormwater Technical Assistance Grant with the City and LandStudies, Inc.; Sent pictures to Laurel Etter-LandStudies for their submission of the Final Grant Report to NFWF
- Reviewed EPCAMR's Summer Watershed Outreach Intern, Spencer Zuraski's John Kaminski Scholarship
  Application essay to provide him with some technical assistance and critique of the document to help him
  improve his chances of obtaining a scholarship from the PA Anthracite Section-SME

- Conducted a phone interview with Anne Daymut-WPCAMR for her upcoming survey results compilation of abandoned mine reclamation community groups comments and responses related to AMD and AML progress in PA; The presentation is anticipated to be presented at the NAAMLP Conference in Lexington, KY in September 2017; Shared the link to the survey online and through our EPCAMR Social Media outlets
- Provided some technical assistance and mine map symbology interpretation to *David Brocca*, the Director of the Knox Mine Disaster documentary that is nearly complete; A general rule of thumb for numbers: If they come in a 00-00-00 format, they are typically dates; They represent the progression of mining at different times; The "s" could also mean stop or surveyed; The maps were originally on linen and were constantly being added to with pencil, then pen; The pencil was a planned course, while the pen was the "final" course; Sometimes these are hard to distinguish on a copy of a copy of a copy; For a number found near a point with a circle around it (survey mark): If it has a 10th, it's usually a floor elevation; The other number has to do with linear distance from some starting point (usually an entrance); It was used in correspondence with the dip to calculate the elevation; For numbers near a bullseye (borehole) symbol, there will be a B.H. number (corresponds to a book somewhere with a stratigraphic column) and a short listing of significant layers and thicknesses; Other symbols include a "v" for vein followed by a number which represents the thickness in feet and "c" for extractable coal thickness in feet; www.knoxminedisaster.com
- Spencer Zuraski informed Phil Thomas-Trout Unlimited that several EPCAMR Staff and volunteers have completed the Aquatic Organism Passage (AOP) Protocol Certification and have surveyed and assessed 20 culverts in the surrounding Wyoming Valley watersheds over the Summer; Continued to assess stream culverts in the Abraham Creek Watershed for the Coldwater Conservation Heritage Plan EPCAMR is working on
- Provided Kristin Sweeney-PA Anthracite Section SME member, with EPCAMR's contact information for Zach Laubach-Commonwealth Equipment, Ashley, PA to see if they were interested in sending a representative to an upcoming August 24th SME Meeting and PADOT Alkali Silica Reaction Talk
- Began working on a NFWF Technical Assistance Grant Application with *Dr. Aaron Clauser* Clauser Environmental, LLC (<a href="www.clauserenvironmental.com">www.clauserenvironmental.com</a>) for a Green Infrastructure planning/design grant up to \$50,000 for some small culvert replacement projects within the City of Wilkes-Barre; Uploaded a Capability Statement to our draft grant application online through NFWF that was obtained from *Dr. Clauser*; Obtained a Letter of Support from the City of Wilkes-Barre in preparation of submitting the grant in mid-September 2017; Forwarded him some previous work that we completed with LandStudies, Inc. on an earlier NFWF Technical Assistance Grant; <a href="http://www.nfwf.org/chesapeake/Pages/tcgp2017rfp.aspx">http://www.nfwf.org/chesapeake/Pages/tcgp2017rfp.aspx</a>
- Provided *Dr. Elizabeth Hughes*, Earth Conservancy, with several reports and documents that list the types of AMD parameters that have been historically monitored in the Nanticoke Creek watershed
- Worked with Mike to complete a Professional Services Contract Proposal for Pagnotti Enterprises to sample 100 AMD discharges in the Anthracite Region at the request of James Pagnotti; Submitted the proposal for his review

• Communicated with Mark Malach, Civil Engineer Manager-PA DEP, about EPCAMR's willingness to assist Ashley Borough with seeking and applying for funds to help to alleviate flooding and stormwater issues with Sulfur Run that is a mining impacted tributary to the Solomon Creek watershed within the municipality; Provided Mark with a copy of our previously submitted Growing Greener Grant from 2015 that was not funded; EPCAMR was approached by a Ashley Borough Councilman, Gerry Maldanado to follow up with the PA DEP on projects and assessments we've completed in the watershed over the years and the Executive Director even researched and prioritized several funding options for the Borough and provided a list to the Borough Manager, Mr. Greg Gulick for his review; EPCAMR realizes that Ashley Borough needs to become a Project Sponsor before any movement on the Sulfur Run project gains traction

- Authorized the placement of \$30 into the Other Budget category in our PA DEP EE Grant for our Plainsville AMD EE STEM Outreach Program with the 6<sup>th</sup> grade Plains-Solomon Elementary students in the Wilkes-Barre Area School District; Prepared the upfront working capital advance for the \$3000 in funds to implement the program and forwarded it to Ann Devine, Project Officer on August 9<sup>th</sup> which was immediately approved and sent for payment

- Informed the Mehoopany Creek Watershed Association (MCWA) that EPCAMR would be awarding them an \$800 ARIPPA Mini-grant to go towards the costs of limestone sand to be placed along the banks of Red Brook Run in the headwaters of the Mehoopany Creek watershed near Coal Bed Swamp on State Game Lands 57
