Education & Outreach

- Attended the *PA Aggregates and Concrete Association (PACA)* Board Meeting, Hershey, PA upon the invitation of *Peter Vlahos*, President of the Board to make a presentation on EPCAMR, our projects, the dependency on the aggregate industry for many of our construction projects, and our outreach support in the region where we would welcome additional partnerships with regional industries and quarries; Forwarded PACA a copy of EPCAMR's Clean Power Plan comments; www.pacaweb.org

- Participated in an NAAEE Webinar hosted by *Lori Mann*, President-NAAEE on EE Capacity and provided her with demographic statistics for our PA Leadership Team upon her request
- Attended Wyoming Seminary's High School STEM Workshop at Nesbitt Hall, Kingston, entitled "*From Waste to Create*", where more than a dozen art students and a few art teachers were instructing the students in the use of iron oxide pigment collected and acquired through EPCAMR in the Wyoming Valley; EPCAMR partnered with the students, art, science, Engineering Club, and STEM teachers earlier in the Fall and provided them with an AMD Tour; <http://timesleader.com/news/local/497223/from-mine-run-off-to-art-at-wyoming-seminary>
- Corresponded with *Carol Parenzan*, the newly hired Middle Susquehanna RiverKeeper, congratulated her on her new position, and invited her to the EPCAMR Region for an AMD Tour in the late Spring, early Summer 2016; www.middlesusquehannariverkeeper.org

- Corresponded with *Liz Hermsen*, Senator Casey's Office, to ask her to send a message to Senator Casey to remain strong in support of his for clean water protections by voting against SB 1140
- Provided Representative *Aaron Kaufer* and his Staff with a presentation on the PennEast proposed Pipeline Project and EPCAMR's initial assessment of the impacts on the underground abandoned mines in the area of the crossing and our organization's 3D mine underground mine pool mapping, and the impacts of a recent legislative bill that passed in the General Assembly that affects mine water pollution that can now be used for fracking oil & gas wells in the Marcellus Shale region of PA
- Signed up to become a partner in the **Delaware River Watershed Coalition** (DRWC) upon the request and referral of *Kate Gibbons*, PennFuture NE Office, who is on a steering committee to facilitate input, information, and funding opportunity sharing up and down the watershed, with the many different issues/concerns; Received a response from *Madeline Urbish*, Assistant Coordinator for the DRWC and invited her to field tour the headwaters of the Delaware in Summer 2016 that is AMD impacted
- EPCAMR signed on to a "Thank You" note through the **Choose Clean Water Coalition** that went to 9/12 Senators in the Chesapeake Bay watershed (excluding Toomey, Manchin and Capito) who voted against the two bills which would have stopped the Clean Water Rule and on to a **Choose Clean Water Coalition** comment letter on the draft *Pipeline Infrastructure Task Force Report*; The comments focused on the need to reference the Bay TMDL in the report, the need to implement water quality monitoring sufficient to ensure PA's compliance with the TMDL, the need to include environmental justice in the report, and the need to have a longer comment period
- Received and reviewed *Vince Brosini's*, Director of Environmental Affairs for Olympus Power, LLC comments on the Clean Power Plan and HB1370 and forwarded him EPCAMR's comments on the Clean Power Plan that were submitted to the PA DEP, EPA, and ARIPPA
- The Wolf Administration plans to propose a major new state investment in conservation and environmental protection-a "**Growing Greener 3**"-in 2016; EPCAMR Executive Director has provided comments in great detail to the large group that has been meeting consistently over the last few months on what we consider to be priorities and comments on criteria development for funding projects; To this end, it's seeking ideas and feedback from interested organizations and EPCAMR has forwarded the survey to our constituents so that they can provide input and shape of the Administration's proposal by answering all or some of the survey questions at <https://www.surveymonkey.com/r/GrowingGreener>
- Talked with *Kelly Horrell*, Western PA Conservancy Grant Program Administrator, about EPCAMR's intent to propose a **\$2000** grant to support organizational promotion and awareness of our organization in two targeted coverage areas of Dominion, who is funding the grant round (one in Tioga and the other in Dauphin County) which are in EPCAMR's service region; EPCAMR has some partnerships in those counties with the County Conservation Districts and a few community groups, however, we would like to dedicate some time and effort to creating more awareness and outreach efforts in these areas that have experienced their fair share of abandoned mine problems and water quality issues dealing with abandoned mine drainage (AMD); Our goal would be to add additional partners to our Coalition where we work and would like to provide additional technical assistance to those community leaders and groups with similar goals and desires to clean up their mining impacted watersheds; *Kelly* thought the project was a great fit, therefore the Executive Director pulled the application together with some assistance from Staff and submitted it on 12-15-15; Received a letter of support from *James Ryan*, President-Babb Creek Watershed Association and *Paul Otruba*, Enviroeneers in Tioga County

- Reviewed a draft piece of legislation from Representative Tommy Sankey, forwarded to EPCAMR by Representative Gerald Mullery, who was interested in our thoughts on the bill that would amend PA 's Act 2 Brownfields environmental cleanup law to address liability issues not taken under consideration under SB 875, now called Act 47, that EPCAMR was opposed to for many reasons; Provided educational and constructive comments to Representative Mullery; Provide him our analysis of US HB 3843 and 3844 as well
- Provided *Thea Shar*, Director of Programs, DiscoverE for Future Cities with information on abandoned mine land reclamation and AMD impacted streams and watersheds; She is directing a UL grant and is coordinating with 40,000 students participating in Future City across the US, China and Egypt, so students are everywhere; She is challenging her teams, made up of middle school students, an educator, and a volunteer mentor, to imagine, research, design, and build cities of the future; Students spend approximately four months creating cities that exist at least 100 years in the future; Each city must incorporate the team's solution to a citywide sustainability challenge (this year is creating public spaces); Students present their vision of the future via a virtual city design (using SimCity); a 1,500-word city description; a scale model; and a presentation to STEM professionals. She likes the idea of adding a grayscapes/brownfields concept to their list of possible reclamation areas; She requested that EPCAMR review a draft of the challenge to offer them feedback
- *Dr. Marianne Krasny*, Cornell U. informed EPCAMR that the SESYNC book was approved by Cornell University Press (as was the *Urban EE Review*—I am sure *Alex Russ* will be sending out an announcement to *Louise* and other authors); The reviewers did has some comments on the chapter authored by the Executive Director and *Louise Chawla*; *Dr. Krasny* will take a look at them after the first of the year and get back to us; She is planning to make the writing style consistent among the chapters so she will be making some edits along those lines to address the reviewer comments and get back to us for approval; We were the first to submit our chapter for review and the work was greatly appreciated
- Corresponded with *Erich Schramm*, EE Coordinator for the Lehigh County Conservation District to welcome him to his new position and invited him up in the headwaters of the Lehigh River in the late Spring, early Summer 2016, to see some AMD projects that we're working on to familiarize himself with groups, partners, and our efforts; EPCAMR could possibly partner on future grants with the Lehigh County Conservation District
- Coordinated and convened a meeting with Wilkes University officials to discuss regional collaboration and AMD watershed projects on 12-18-15; Provided all partners of interest with a tentative agenda, topics for discussion, and bullet points of work that is currently ongoing in the region where EPCAMR can use the support of the University
- EPCAMR was approved as a PA DCNR "Get Outdoors PA Community Partner"; <http://getoutdoorspa.org/>

- EPCAMR will be assisting with promoting various Mining History Month events throughout Northeastern PA starting in early January 2016; The regional observance of Mining History Month will take place January 9-31st, 2016, with programs in Wilkes-Barre, Scranton, Pittston, Port Griffith, Plymouth, Nanticoke, Ashley, and Wilkes-Barre Township; The annual event seeks to remember and honor the area's anthracite mineworkers, their families and communities; The programs are sponsored by the Anthracite Heritage Museum, Anthracite Heritage Foundation, King's College, Wilkes University, Lackawanna Historical Society, Barnes & Noble, EPCAMR, Luzerne County Historical Society, Luzerne County Community College, Greater Pittston Historical Society, Plymouth Historical Society, Nanticoke Historical Society, Huber Breaker Preservation Society, Anthracite Living History Group, and Knox Mine Disaster Memorial Committee; All events except the first are open to the public free of charge

Technical Assistance

- Met with *Dr. Lowell Sieck*, Ph. D. and *Craig Stevens*, CSI Environmental, LLC to discuss a new water filtration AMD treatment technology that they have patented and are looking to pilot in the Anthracite Region; Provided them with an AMD Tour of the Southern Wyoming Valley to several discharge locations to grab mine water samples and provided them with water quality and quantity information that EPCAMR had in our database and corrected some information they provided to us in their summary notes from the tour of the southern Wyoming Valley AMD discharges; Updated *Tom Clark-SRBC* AMD Coordinator about our meeting; Provided a link to *Derrick Thorn*, intern for CSI to the www.minemaps.psu.edu website where all of the EPCAMR maps have been uploaded for cloud storage on the Penn-State server; *Kevin Costello*, CSI Environmental, LLC has been supporting their efforts regarding AMD treatment and has been coordinating with personnel at Willowstick Technologies (WT); WT provided a Webinar on 12-10-15 to explain their Willowstick investigative tool and answer questions which seemed of interest to some EPCAMR partners in the region, including SRBC and the LRCA; Provided *Dr. Sieck* with contacts at the Pottsville District Mining Office to discuss the Temporary Discharge Authorization (TDA) related to the Wyoming Valley AMD discharges
- Drafted an Internship document Activity Description for a potential Community Development Specialist position for the Huber Breaker Preservation Society and forwarded it to *Pat Kennedy*, from their Board for review and use; Provided *Michele Casey*, Secretary, with the contact information for Dr. Bolan, King's College, Director for the Shoal Center for Community Engagement and Learning, Wilkes-Barre for her to send a "thank-you memo" for the students who helped at the Park digging the trench, constructing the picnic table, and other landscaping projects in November; Sent along another batch (*Batch 10*) of 21 pavers to Olde Mill Impressions
- Reviewed OSM TIPS Service Management Plan update from *Tom Koptchak*; Provided *Arielle Avishai*, OSM, with some information on EPCAMR's use of GIS symbology for our RAMLIS Community Tool for her and other committee members to look from the GeoSpatial Data Standards Team
- Provided *Elizabeth Hughes*, EC, with a list of local community groups and partners at her request for an EPA Brownfields proposal that EPCAMR is supporting for the continued remediation and reclamation in the Espy Run watershed of the Nanticoke Creek, Luzerne County; Prepared a Letter of Commitment for the EC Brownfields Grant application and provided it to *Elizabeth*

- Reached out to *Nate Zalik*, PA Game Commission Wildlife Biologist, to inquire as to whether or not a freshwater mussel survey on the populations and the impacts from the many contributing AMD tributaries has occurred on the N. Branch of the Susquehanna River (from Harding, PA south to the Lackawanna River confluence near W. Pittston, PA from the Lackawanna Valley, to the southern terminus of the Wyoming Valley, near Shickshinny and Mocanaqua, PA); EPCAMR was a member of the Habitat Advisory Committee that helped to develop the PGC Wildlife Habitat Plan and the previous update and worked with *Catherine Haffner*, EPCAMR is interested in pursuing the development of a partnership in our area to potentially submit a grant to perform such work with one or more of our local colleges and our County Conservation District Watershed Specialist in Luzerne County (John Levitsky) in the area (Wilkes University or King's College); EPCAMR would ultimately like to make a case to other funders in the lower portion of the Chesapeake Bay (tide water areas) that water quality improvements in the upper reaches of the Bay (and funding that may come from the lower reaches potentially) can have a huge impact on increasing and improving the freshwater mussel populations and diversity of species along the entire drainage area to the Bay, if it is warranted; EPCAMR is very interested in pursuing such a study, research effort, and field investigation, if there is some funding available. We have kayaks, staff who are trained in water quality monitoring and conducting watershed assessments, macro-invertebrate assessments and identification, and work on many other environmental education and community outreach projects and programs throughout the AMD impacted regions of the Northern Anthracite Coalfields; We believe that there might be an indication of deleterious impacts to the populations and diversity of species based on taking a closer look at the shells of the freshwater mussels and the calcium deficiency or ability to filter iron oxide sediments through their bodies. What we don't know is if there is an overall cumulative effect on the populations above and below the AMD impacted areas, so we'd like to investigate and test our hypothesis further; EPCAMR was referred to Diana Day, PA Fish & Boat Commission; She forwarded EPCAMR two recent studies and looked forward to our partnership in the future should some funding become available; The Middle Susquehanna was surveyed in 2009, but not in great detail in the area EPCAMR had inquired about where the AMD impacts were most prevalent
- Jim Gusek*, Sovereign Consulting, CO, provided EPCAMR with three published papers that may have some relevance to suppressing ARD/AMD in the Susquehanna River Basin, especially in the "beach zone" of coal slurry deposits that may have been backfilled into underground mines or coarse coal refuse piles; Of particular interest is the potential beneficial use of waste milk in suppression of AMD in pyritic coal waste; Sovereign participated in a follow-up, better-controlled experiment at a coal mine site in eastern Tennessee and the preliminary results were promising; It appears that waste milk (or fresh milk for that matter) has a "heat seeking missile" characteristic: when the casein protein in milk encounters a pH below 4.6, it degrades into your standard curds and whey, effectively coating pyrite surfaces with an organic biofilm where beneficial microbes out-compete *Acidithiobacillus ferrooxidans*, basically shutting down the AMD production process; The "milk process" is patented but the patent holders (Western Research Institute in Laramie, WY) and they aren't greedy and Sovereign is poised to obtain a license to use the technology; Under the right design conditions, the benefits of milk application might be sustainable or semi-permanent; Jim would like to get together with EPCAMR, EC, and EPCAMR would like to bring in the SRBC to discuss any potential sites in the future; EPCAMR followed up and will follow up again after the New Year

- Lewis Mine AMD Rehabilitation Project;** Reviewed PA DEP Moshannon District Mining Office Surface Mine Inspector-*Aaron Pontzer's* Inspection Report of the progress being made on the construction project; Submitted a 5th invoice and progress report on 11-3-15 to confirm completion of the construction project; Included Rexer's LLC Invoices and Reports; On 11-5-15, *Aaron Pontzer*-PA DEP Moshannon Office visited the site with *Chris Hartman*, the PA DEP Operation & Maintenance contractor to show him the site before Winter set in; On 11-24-15, EPCAMR visited the site to inspect the final construction rehabilitation elements of the AMD Treatment system with all partners, including PA DEP Moshannon DMO, *Corey Richmond*-Watershed Specialist-Sullivan County Conservation District, *Marc Lewis* (landowner), and Rexers LLC (the contractor); Provided *Corey* with a few photos for inclusion in a report that he was giving to the Sullivan County Conservation District Board and had *Gabby* post some pictures on our EPCAMR social media site; Updated Reimbursement 4th Invoice for *Eric Rosengrant*, PA DEP Moshannon DMO and Invoice #5 that had a few minor errors; *Marc* was very pleased with the final rehabilitation and construction of the project and informed us that there was no need to keep the access road open to the lower wetland pond and is fine with blocking it off according to PA DOT specifications; Received a letter from the Grants Center regarding our completion percentage of the grant standing at 85%, therefore, they were withholding \$11,776.70 from the Construction category to pay Rexer's LLC, pending a receipt of a Final Report. The grant overall has reached 65%, therefore, \$17,598.00 was deducted for Working Capital, so essentially, EPCAMR was provided with a reimbursement for \$0.00 and became thoroughly confused; We need to wait for the road to be closed and a final Invoice from Hedin before we can officially close the project and submit a Final Report along with a Final Inspection by *Aaron Pontzer*, PA DEP Moshannon Office; Corresponded with *Eric Rosengrant*, our Project Officer, who said he would review it after the Holidays since they will be on vacation the last week of the year
- Reviewed *Patrick Jaquay's* comments on EPCAMR's submissions of mine map work from September and October 2015 and the minor corrections that needed to be updated and resubmitted under the **MSI Mine Map Project;** Forwarded to *Kelsey* for review
- Hicks Creek Natural Stream Channel Design Project;** Mike took some time to geo-reference the mine maps and the cross-section map from the OSM Folio Series in the area of our project and we provided them to Skelly & Loy, for point of reference; We think that pulling the stream back a little further away from the road on the first turn might keep more of the baseflow on the surface; We don't believe it needs a change in the design, we just think we should talk about it when we eventually get to the site showing; The flow seems to be pulled right into an old slope that is backfilled in that area; It would be important to note this location on the first turn due to the use of heavy equipment in that area; Mike tied them in to the surface maps and the underground mine maps in that area
- Received notice and funds from **NOAA/Chesapeake Bay Trust Mini-EE** grant for **\$3549** To develop AMD Models with STEM students from Wilkes-Barre Area School District's EL Meyers HS following an AMD Tour involving several investigative experiences; Forwarded a letter of support from the Wilkes-Barre Area School District through *Mike Corcoran*
- NFWF grant funded our joint technical assistance proposal entitled, **Retaining Stormwater: Green Infrastructure Practices for the City of Wilkes-Barre, PA** under the Chesapeake Bay Technical Capacity grant program, with LandStudies for the City of Wilkes-Barre in the amount of **\$33,300;** Provided *Dan Przywara*, LandStudies, with some details on the Hollenback Park and Golf Course that they needed for the revision necessary in the grant before it was finalized

- Provided Gabby and Liz *Tony Brook's* contact information in case they needed to contact him about the history of the City of Wilkes-Barre related to the Solomon Creek Canal basin along Martin Luther King Boulevard, any collieries in that area, the railroad, and the Ellis Roberts E.
