# **February 2016 Progress Report**

#### **Education & Outreach**

- Worked with EPCAMR Staff to create an ETSY online account for the sale of recycled iron oxide products created by EPCAMR
- Conducted an AMD & Energy Education Program at the Hazelton STEM School with Estelle Ruppert-Green Schools/Blue Waters Program with Mr. Benjamin Evancho's class of 28 students; Forwarded EPCAMR Executive Director's clearances to the school to follow safety protocol
- Met with Estelle Ruppert following our AMD & Energy Education Program on our upcoming EE Capacity Workshop at the PAEE Conference on 3-15-16, at the Inn at Pocono Manor, Poconos; Participated in an EE Capacity Workshop conference call with the PA Leadership Team: Held another conference call to develop our PA EE Capacity presentation for the NAAEE Webinar

#### **Technical Assistance**

- EPCAMR Staff participated in a conference call with CSI Environmental, LLC and partners to discuss
  an outline and scope of work for the proposed *Mocanaqua AMD Tunnel Mine Pool Feasibility Project* that we're interested in developing in partnership with the SRBC as a consumptive use
  mitigation project; Participated in a second call with CSI Environmental, LLC and partners with the
  SRBC to discuss further details based on the phased scope of work developed for the project
- Met with Hank Zelinsky, Northampton Fuels Supply, to discuss opportunities to partner with the Co-Generation plants on future reclamation projects in the region and come up with project locations for discussion of the development of reclamation plans throughout the Anthracite Region; Scheduled a field tour in the Hazleton Area in late March 2016
- Worked with Butch Frati-City of Wilkes-Barre to obtain the 2014-2015 Audits for the City to provide LandStudies for the NFWF Program, who are in the process of reviewing the fiscal documents submitted with the Full Proposal for Project #51065 - "Retaining Stormwater: Green Infrastructure Practices for the City of Wilkes-Barre, PA"
- Provided Robert Frank, new Watershed Specialist for the Dauphin County Conservation District with some technical assistance, links, resources, and contacts for groups working on AMD and mine reclamation work in his area; Asked him to check with his District Manager to see if he can become appointed to the EPCAMR Board to represent the District throughout the year
- Followed up with *Dr. Brian Mangan*, Professor of Environmental Science and Biology, King's College
  who is working with a colleague from Susquehanna University on a project related to mercury
  contamination at mine fire sites and the levels that are contained within spiders found in those

- Provided Gabby with two research papers on freshwater mussels in the Susquehanna River basin from Diane Day from the PA F & BC

# **Community Volunteer Service Coordination**

- Co-presented with Ray Clarke-Chairman of the Huber Breaker Preservation Society to Dr. Margarita Rose's Environmental Economics Class at King's College, Wilkes-Barre on the reclamation of the Huber Miner's Memorial Park; The Class is working on a semester long service learning project in partnership with EPCAMR and the HBPS to conduct a community survey, an economic analyses report, and a community cleanup project at the site towards the end of the semester in May 2016
- Communicated with Wesley Mech, Nanticoke, PA who signed up to volunteer with EPCAMR through GiveGab and informed him of upcoming activities with EPCAMR

- Worked with Gabby and Dave to come up with a list of Stream Assessment Sites Map that could use water sampling and macro-invertebrate sampling done on them in the Wyoming Valley and be placed into a GIS layer for future volunteers
- Casey McCauley, Slippery Rock, PA signed up to become an EPCAMR Volunteer through GiveGab, and has expertise in strategic communications and would like to volunteer virtually to help us with brochures or flyer development

Completed the Lewis AMD Rehabilitation Treatment System Project Final Report and other Worksheets and forwarded them to our Project Office Eric Rosengrant-PA DEP DMO; Copied Marc Lewis, the landowner in on the project update out of common courtesy; Submitted before and after photos to Eric as well and placed dozens of others on to a DVD and mailed them to the Moshannon District Mining Office; Talked with Rexers, LLC to inform them that their final payment would be forthcoming when the Final Report and water quality tests were back from the lab to be included with the final results

- Followed up with *Ben Lorson*, PA F&BC on the **Solomon Creek Dam Removal and Trout Stream Habitat Improvement Project**, Ashley, PA on how to proceed with getting the design and construction contracts together with RiverLogistics and with Larson Design Group for the permitting, restoration Chapter 105.12 waiver application, and E & S plan submission and approval to the Luzerne Conservation District
