• Reviewed the application before preparing and applying for a **\$20K** grant to monitor, daylight, and inform road departments in various municipalities, County Road and Bridge Departments, and PA DOT, in both Counties about the boreholes that have been historically used to monitor the underground mine pools; Some of them have been paved over inadvertently because they are not on the PA One Call System; Reached out to *Susan Turcmanovich*-PA American Water to let her know about the project that we are proposing to submit

## US DOE Capacity Building for Repurposing Energy Assets at the Frackville Morea AML Complex for Floating Solar and Geothermal Potential

• Frank Sindaco-EPCAMR GIS Watershed Outreach Specialist provided a draft of the research and project analysis to date on the project; The data needs more exploration and refinement; It is a mix of info, resources explored that had info and some overall project systems; Provided Frank with focus areas, other ideas to add to the research; Frank is going to set aside some time to work on an Exemplar Report: Frank reviewed Mark Jones's extensive DOE and energy communities info: Recent Executive Orders and other administrative actions and court decisions have given rise to some uncertainty surrounding DOE programs and funding; Based on a recent Notice issued by DOE in response to a court order, on 2-7-25 and again on 2-14-25, EnergyWerx's understanding is that DOE is not currently authorized to suspend any payments; Nonetheless, given the recent activity, there is some risk that payments may be delayed; EnergyWerx was hopeful that with Chris Wright being confirmed as Secretary of Energy on February 3, 2025, his team will be able to complete their internal reviews and provide guidance on the way forward in the near future; Worked on informational flyer and meeting agenda for the 2-25-25 meeting in Canva with Morgan; Communicated with Melissa Brannen, from Penn-State on the development of the subcontract agreement and the scope of work for Penn-State that has been delayed due to the Executive Order and Memo provided to EPCAMR from EnergyWerx and US DOE and informed her that EPCAMR would be discussing the situation at our upcoming Board Meeting; EPCAMR read the EO, that was forwarded to Melissa, as conflicting and confusing as to whether we fall under these EOs or not, since we aren't sure that our project is considered a part of the "Green New Deal", the Bipartisan

Infrastructure Law, or some of the other previous Administration's initiatives under former President Biden: Submitted revised format of Exemplar for Milestone 3 completion of the project to EnergyWerx and working with *Frank Sindaco*-EPCAMR GIS Watershed Outreach Specialist; Discussed with Frank the development a Community Data App for the focus area around the project that could be expanded to the EPCAMR Region that surround the area to provide important data sets, demographics, and a number of other categories of relevant data that could help communities, local governments, economic development groups, colleges, universities, and non-profits extract and export relevant data for future grant projects to help with need justifications and planning purposes; Sent out the invite to the informational meeting in Frackville at the Schuylkill Center for Technology on 2-25-25; Stakeholders RSVP'd for the Informational Meeting on the project; Confirmed the logistics and setup of the meeting with Chris Groody-Schuylkill Center for Technology: Convened the meeting that was well attended by **26** stakeholder groups: Provided a quick guide to Energy Communities Assistance Program created by Mark Jones-EPCAMR Community Development Coordinator AmeriCorps volunteer; Executive Director made a presentation and provided an overview of the project as well as sought input from the audience members; Researched information on Datacenters and Servers

- EPCAMR provided the NEPA Alliance and Non-Profit Community Assistance Center (NCAC) with information on the InterAgency Working Group's Energy Community Assistance Program; The Stewards Individual Placements program within the nonprofit Conservation Legacy coordinates the AmeriCorps VISTA component of this initiative and EPCAMR provided it to NEPA Alliance; Forwarded membership information to NCAC to *Eric Null*-Executive Director of the PA Council of Trout Unlimited
- Provided Eric Null-PA Council of Trout Unlimited with a letter of support for his grant application to PA DCNR to utilize our EC/EPCAMR Conference Room valued at \$300/day for a future State-wide Meeting of the PA Council of Trout Unlimited's Executive Committee

- Scheduled a meeting on 3-18-25 with *Harry Hoy*-PA DEP Office of Environmental Justice who is working with *Jordi Comas*, NC Regional Coordinator to update the <u>PennEnviroScreen</u>; They had some questions about the Abandoned Mining Concerns indicator, specifically the abandoned mine lands inventory; EPCAMR encouraged Harry to look at our RAMLIS GIS Tool that is very comprehensive; One significant point of interest related to AML and AMD impacted areas is that often an AMD discharge point might be only seen as the EJ point of significance and the census block around it is impacted by default, however, it doesn't often take into consideration the entire downstream segments of the stream or impaired reach until the segment is designated as another level of attainment when it comes to water quality; A much larger buffer is necessary or why not designate the entire watershed or subwatershed that is impacted by both AMD and AML; We're not even talking about the underground mining aspects; That doesn't get half the attention it deserves; Mine subsidence is a real issue and hazard; Flooding of mine pools is another; Encouraged him to look at the Mine Map Atlas (www.minemaps.psu.edu) for a different picture of what is really an injustice on another level
- Scheduled a Zoom meeting on 3-11-25 with Tara Jones, Paul Davis, Bernie McGurl-Lackawanna <u>River Conservation Association</u> (LRCA), and Tom Clark-Kleinfelder, to discuss an alternative AMD Treatment approach to the Old Forge Borehole
