**July 2014 Progress Report** 

#### **Education & Outreach**

- Attended a meeting in Harrisburg, PA at the PA Fish & Boat Commission's SC Regional Office to provide input into the PA Game Commission's State Wildlife Plan as a part of the PGC Wildlife Habitat Planning Technical Committee; EPCAMR provided unique input to the plan related to bats, herps, and wildlife that are encountered on abandoned mine lands, underground abandoned mines, and reclaimed abandoned mine sites; Cathy Haffner, Wildlife Biologist and Conservation Planning Coordinator provided EPCAMR with a new data set; The terrestrial and aquatic habitat classification systems, along with other analyses (e.g., landscape resilience), are available through the Nature Conservancy Conservation Gateway: https://www.conservationgateway.org/ConservationByGeography/NorthAmerica/UnitedStates/edc/reportsdata/m apsdata/Pages/default.aspx
- Continued writing a draft outline on EPCAMR's Urban EE Programs and Case Studies for a Chapter with the Urban EE Group with Cornell University and EE Capacity in partnership with the US EPA and partnered with Sheena Falconer-who works on watershed work in British Columbia who is interested in co-authoring the Chapter; Followed up with Ruth Roperti, PAEE about attendance at the NAAEE Conference in Canada in October 2014, where representatives of the PA Consortia will be allowed to attend on scholarship to present and be a part of a series of workshops and panel discussions; EPCAMR submitted a presentation proposal at the request of the NAAEE President Lori Mann and it was accepted
- Provided a final evaluation to Professor Elaine Reeder, for Tatiana Markovich, EPCAMR's Graphics Design Intern from Camden County Community College, Camden NJ, that worked with EPCAMR virtually for nearly 3 months to complete several projects as a part of her internship experience
- EPCAMR signed on to a support letter from Clean Water Action that will be going to the US EPA in support of the Clean Water Act after a phone call from Liz Higgins, Clean Water Action

#### **Technical Assistance**

- EPCAMR Watershed Outreach Specialists, Elizabeth Rosser and, Dana Sword began working on the EC Trails that EPCAMR will be marking for the month of July and August 2014 on 3 different trail systems in the Southern Wyoming Valley
- Contacted PA DEP BAMR to see if EPCAMR could assist the Huber Breaker Preservation Society with obtaining the Pink Ash Fan, from the Pink Ash Colliery, all the way up in the tip of the Northern Fields, near Forest City, from a reclamation job that is currently being undertaken by the Commonwealth; The HBPS would like to have it placed within the Huber Miner's Memorial Park; HBPS may need a flat bed truck to obtain and haul the fan from the site

- Completed field work with Blake Maurer-SRBC Intern, at several AMD discharges around the EPCAMR Region
  to place staff gages to assist with future monitoring of mine discharge flows from the Solomon Creek Boreholes,
  Askam Boreholes, and the Duryea Breach (the gage was not able to be installed here due to a recent creation of
  a beaver dam)
- Provided a letter of support to the Earth Conservancy for their Bliss Blank Abandoned Mine Reclamation
   Project Phase II Growing Greener Project
- James Glenn, Pollock Enterprises forwarded EPCAMR several shots of illegal dumping going on in the Newport Creek Watershed, near Whitney Pointe, just outside of Honey Pot, near Nanticoke, PA and was seeking our assistance in coordinating a future cleanup of the area in the Fall 2014
- EPCAMR worked on a Growing Greener proposal to provide *Technical Flow Monitoring, Chemical Loading Monitoring, 3D Mine Pool Modeling and Mapping throughout the EPCAMR Region*; Submitted the proposal
- EPCAMR worked on another Growing Greener proposal to **Study Plumbing for limestone type tank AMD Treatment Systems** in partnership with Hedin Environmental, Babb Creek Watershed Association, Catawissa Creek Restoration Association, Schuylkill Conservation District, and the Columbia County Conservation District; Submitted the proposal
- Provided a letter of support to Kate Totino, Grants and Gift Research Manager for Misericordia University for a STEM Proposal that the University is submitting; EPCAMR Executive Director would be an invited guest speaker for college students on environmental careers in the STEM field
- OSM provided EPCAMR with a free sampling plan design and statistical analysis program software package due to our affiliation with the TIPS Program; <a href="http://vsp.pnnl.gov/">http://vsp.pnnl.gov/</a>
- Meeting with Dan Summa, CEO/Founder of Keystone Pure Water Tech Inc. to discuss the Scranton Lace Works Redevelopment Geothermal Project that will utilize mine water from within the Scranton-Metro Mine Pool Complex; EPCAMR has assisted with a CFA Application with the private company; Provided Dan with a Letter of Support for the project
- EPCAMR looked for geologic cross sections of the Lackawanna Valley near Dickson City, where the K-Mart is located at the request of *Martin Gilgallon*, P.G. for *PA Tectonics, Inc.*; None were found and reported back; OSM Folios for the Cayuga & Storrs Colliery (their approximate original contours): 90, 900, 9P and 9U were found however
- Informed by Joe Dal Santo, high school student from Wyoming Valley West, that he received his Eagle Scout
  Badge by passing his Board of Review from the Boy Scouts of America, following his volunteer work to plant
  trees in EPCAMR's Waterboxxes at the Espy Run AMD Treatment location on Earth Conservancy property in
  the Nanticoke Creek Watershed
- Provided *Jim Wetzel*, Weatherly Borough, PA volunteer with a link to hydrographs in the White Haven area so that he can see the precipitation data around Hazle Creek for the *Hazle Creek QHUP Development Project*

## **Project Coordination**

Attended the Ashley Borough Council Meeting on June 1st to provide them with an overview of the **Solomon Creek Trout Stream Habitat Improvement and Dam Removal Project** that EPCAMR is working on in partnership with the PA Fish & Boat Commission, PA DOT, Stanley Cooper Chapter of Trout Unlimited, and the Ashley Trout Stocking Association; Mitigation funding is available through PA DOT and EPCAMR is working on developing a Scope of Work, Budget, and Cooperative Agreement that could be completed by the Fall of 2014 with the PA Fish & Boat Commission that will be between (\$100-136K) and take a year to complete; Much of the fill can be used onsite to improve the borough road leading into the park area; EPCAMR obtained a parcel boundary file from Earth Conservancy and provided it to PA Fish & Boat Commission

- EPCAMR Staff and Watershed Outreach Specialists assisted Ray Clarke, from the Huber Breaker Preservation Society, with publicizing a volunteer event on Facebook and through an article in the Citizen's Voice written by Bill Wellock, for the *Huber Colliery Sign Restoration Project* and setting up the 40' Huber Colliery sign on horses at the *Huber Miner's Memorial Park*, Ashley, PA prior to scraping, priming, and painting it for future construction at an entranceway into the Park along the Memorial; Updated the HBPS brochure
- EPCAMR coordinated and organized a field trip to Centralia, PA, the location of one of the more famous mine fire's in the country from the 1960's and surveyed the borough and surrounding area for a planned future *Fall 2014 Illegal Dump Site Cleanup in Centralia Project* in partnership with the PEC NE Office, International Coastal Cleanup organization, Keep PA Beautiful, Bridgestone Tire, ARIPPA, former Drexel University film students, the Commonwealth of PA, and two coal companies (Pagnotti Enterprises and Blaschok Coal); Joe is working on a fundraising promo for the Fall Cleanup; EPCAMR was featured in the short documentary on Centralia recently; <a href="http://vimeo.com/96612018">http://vimeo.com/96612018</a>
- Attended the Nanticoke City Council Meeting on July 16<sup>th</sup> to provide the Mayor and Council with an overview of

  prepared and submitted on behalf of the City; LRCA provided EPCAMR with lots of resources on stormwater
  management, green infrastructure, and materials to assist with the development of the grant application
- Attended a meeting with Susquehanna Mining Solutions, LLC (SMS) and other partners in Harrisburg, PA at the SRBC to discuss a recently submitted Consumptive Use Mitigation Proposal for the Old Forge AMD Boreholes for funding consideration
- Neil Wolfe, P.E., Hedin Environmental received the approval to go ahead with the change in construction plans
  for the Lewis Mine Treatment System Rehabilitation Project; Hedin is beginning to put the bid documents
  together so that EPCAMR can get some contractors out to the site in the late Summer, early Fall 2014
