## **Capacity Building:**

- Wrote and submitted application to PACD's Nonpoint Source Pollution Educational Mini-Grant Program for Conservation Districts; asked for \$2000 funding to purchase a kiln for processing iron oxide, and to pay to run educational programming on uses of the iron oxide as a pigment in classroom and professional art projects.
- Applied for training at Bauen Arts Camp in Wyoming (a nonprofit overnight art camp for teens) to gain skills in working with youth to use art as a tool for social change.
- Received approval for Greater Pittston Historical Society's ACCWT Summer Associate work plan.
- Began preliminary efforts to incorporate Basic Engagement Plan into OSM/VISTA work plan in order to gain an additional \$1000 for EPCAMR from the ACCWT.

# **Watershed Projects & Monitoring:**

- Wrote letter of support for Dale Freudenberger and the Growing Greener application to sponsor an OSM/VISTA Anthracite Team.
- Collected iron oxide from Earth Conservancy's Phase II Wetlands.

#### **Education & Outreach:**

- Wrote press release for AmeriCorps Week; submitted to local papers.
- Provided photos and information on OSM/VISTA program to Ed Zygmunt, field representative for Congressman Chris Carney; appeared in AmeriCorps Week article in Congressman Carney's newsletter.
- Attended Community Connections watershed field trip final student presentations in Scranton and Pittston.
- Coordinated arts segment of three field trips (approx. 240 students) to Canal Park and Honeypot AMD discharge with Dallas Elementary 5<sup>th</sup>-graders.
- Assisted in water monitoring and tie-dying with 48 4th-grade students at Blossburg Elementary in Tioga County.

- Prepared and shipped recovered iron oxide pigment to Zach Zdanek (21<sup>st</sup> Century Patch, WV) and Kari (Friends of Decker's Creek, WV).
