- Provided Eugene Richard-American Mushroom Institute/Community Awareness Committee with contact
 information for the Shamokin Creek Restoration Alliance related to the Site 15 AMD Treatment System and for
 Dave Kaleta-Wildlife for Habitat, for a Spent Mushroom Substrate Compost (SMS) project in Northumberland
 County to reclaim some land near a WALMART; The project starts in April 2010; Asked Mike to forward any
 related water quality information on the Site
- Received the AMD Monitoring Plan Recommendations for the Black Creek, Carbon and Luzerne Counties from
 Jim Wetzel-Weatherly Borough Planning Commission; The Technical Report was provided by Hedin
 Environmental through the Trout Unlimited AMD Technical Assistance Program; EPCAMR Staff to review and
 provide comments to the WBPC on future monitoring plans and EPCAMR's involvement and continued
 assistance with the project along with other partners-BAMR, Wildlands Conservancy, Cabot Corporation, and
 Carbon County Conservation District

- Put Abigail Pattishall, Ph. D. and Director of the Rivers Conservation Program at the Wildlands Conservancy in touch with WPCAMR to see if there is a possibility of getting emergency funding to the tune of \$7000 for the Buck Mountain #2 AMD treatment system in Luzerne County; The system has been leaking and causing water problems for the residents at the bottom of the hill; Wildlands had a contractor excavated part of the system and saw that pretty much everywhere pipes are joined there was a leak; The engineer and the contractor have determined that the fittings need to be replaced; Asked Mike to follow up with her and Bruce to see if any funding was available through their Quick Response AMD Treatment OM & R Grant
- Provided a Letter of Recommendation for Kyra Norton-former EPCAMR intern and active volunteer with the
 organization to the Delaware County Planning Department in New York, as she begins to seek job opportunities
 in the work force when she graduates this semester
- Bill Toffey-Effluential Synergies LLC (http://www.effluentialsynergies.com/) was discussing PSU Researcher, Rick Stewhouer's research into high growth rate biomass/biofuel crops that would be suited for reclaimed land recently and EPCAMR's name came up; Bill has been looking for a useful project to undertake, and thought that building on his water, land and residuals experiences might bring me to a project that would combine nutrient and carbon management issues with the opportunity afforded to both in helping reclaim land in the eastern PA mining district; He was wondering if EPCAMR would have any insight as to how he might advance a project for alternative energy production on mine land areas; EPCAMR forwarded him to the Pocono NE RC & DC who are working on similar projects with EPCAMR already

 outstanding bills; EPCAMR has only been receiving invoices with no progress reports; Percentages of work
 completed on the invoices don't qualify as progress reports.
