### **Capacity Building:**

- Worked on Lackawanna Heritage Valley Authority Educational Mini-Grant for elementary school iron oxide chalk-making projects; requesting maximum grant amount of \$500.
- Wrote and mailed invitations to fifteen local representatives, state representatives, senators, and congresspeople for Scranton Area Foundation/Partners in the Arts mini-grant awards ceremony.
- Participated in follow-up conference call on AMR Conference held in State College in August; received feedback on joint presentation with Savanna Lyons and Catherine Webster (ACCWT OSM/VISTAs); began planning for 2009 AMR Conference.
- Participated in conference call detailing workings of Basic Engagement Plan; sent preliminary progress report to Stacy Bouchard, ACCWT Civic Engagement Coordinator.
- Registered for northern Appalachian Coalfields Watershed Training at Canaan Valley Resort, WV, in late October.

#### **Watershed Projects & Monitoring:**

- Requested Grand Tunnel chemical and flow monitoring data from volunteer Curtis Smith.
- Performed water quality monitoring, including chemical testing and flows, at Honeypot in Nanticoke, Grand Tunnel in Plymouth Township, and the Plainsville Bore Hole in Plains.
- Assembled water monitoring instructions binder for Kathryn Krulack, new Jeddo/Nescopeck OSM/VISTA; trained in flow, chemical, and macroinvertebrate monitoring techniques.
- Processed and prepared iron oxide for tie-dye events.
- Participated in DCNR/PA Cleanways Lackawanna State Forest Land cleanup in West Nanticoke and Avondale Hill, at which 16 volunteers in 4 hours removed 13.7 tons of trash and 145 tires for recycling.
